2 Progress this Quarter

2.1 Planning Approvals and Management Plan Status

CEMP and sub-plans have been split into Stabling and Maintenance Facility (SaMF) and Whole Alignment plans where appropriate.

The following SaMF specific plans have been approved/endorsed:

- Construction Environmental Management Plan (main body)
- Flora and Fauna Management Plan
- Construction Flood Management Plan
- Soil and Water Management Plan
- Transport, Traffic and Access Management Plan
- Waste and Resource Management Plan
- Air Quality Management Plan
- Contaminated Lands Management Plan.

The following Whole Alignment Plans have been submitted to DPIE for approval:

- Heritage Management Plan
- Construction Noise and Vibration Management Plan
- Construction Noise and Vibration Monitoring Program.

The following Whole Alignment plans are currently in development or pending consultation with expected submission dates in Q1 2021:

- Construction Environmental Management Plan (main body)
- Flora and Fauna Management Plan
- Construction Flood Management Plan
- Soil and Water Management Plan
- Transport, Traffic and Access Management Plan
- Air Quality Management Plan
- Contaminated Lands Management Plan.

The Site Establishment Management Plan (SEMP) for the SaMF was submitted to the relevant government authorities and the City of Parramatta Council for consultation.

Project briefing held with NSW EPA on 17/12/2020 on SOM scope and application of the Rail Infrastructure Noise Guidelines with respect to ONVR development.

Consultation with Heritage Office conducted Tuesday 27/10/2020 regarding design at Dundas and Carlingford stops, and implications for implementation of interpretive material.

2.1.1 Pre-Construction Minor Works Approval Status

GRCLR-PCMWA-004 (Geotechnical):

- Approved by TfNSW 02/09/2020
- Extension request approved 17/12/2020.

GRCLR-PCMWA 005 (CCTV and Survey):

- Endorsed by ER 18/06/2020 and approved by TfNSW on 25/06/2020
- Extension request approved 17/12/2020.

2.1.2 Consistency Assessments Status

Currently being prepared by SOM for the following items:

- Tetra towers
- · Height of the Administration and Maintenance building at SaMF
- Use of the SaMF site as a Construction Compound.

Currently being undertaken by TfNSW (with review by SOM):

• Ground level height increase at SaMF site.

2.2 Environmental Audits and Training

Project Audit Schedule developed to ensure project audit requirements are met.

No audits conducted during Q4 2020.

Various training packages in development and training/toolbox meeting schedule drafted for implementation at the commencement of construction.

2.3 Interface Matters

Interface meetings with PCPLR occurred on 10/11/2020. Interface meetings scheduled to recommence in Q1 2021.

Ongoing weekly SOM/Remediation Contractor interface meetings and workshops are occurring.

2.4 Conditions of Approval

Reports and notifications to DPIE required under Schedule 1 of the Planning Approval (Application No. SSI 8285) are listed below in Attachment 1 which includes a SOM status update reflecting progress against each reporting requirement.

Detailed Conditions of Approval compliance reporting addressing SOM progress against CoA and REMM requirements is undertaken quarterly in INX.

2.5 Environmental Design Requirements

The SOM Environment, Planning and Sustainability (EPS) team has been working closely with the Design team to review design packages and ensure compliance with the CoA, REMMs and EPOs relevant to design.

Environmental Design Review Reports (EDRRs) are being prepared with each design package submitted for Detailed Design Review (DDR).

Status of EDRRs for Q4 2020 is provided in Table 1.

2.6.3 Progress of the Tree Plantings

No tree planting activities were planned or undertaken during this quarter.

2.7 Compliance reporting against the CEMP

The CEMP is not an active document until commencement of construction works. Compliance reporting against the CEMP will commence in the first reporting period after the commencement of construction.
